(AS AMENDED)

WHEREAS it is found necessary to amend and alter certain provisions of the Instrument of Nankana Sahib Education Trust; serecuted on the Thirteenth day of January, Nineteen Hundred and Fifty Pour, and registered at Ludhiana on the Eighteenth day of January, Wineteen Hundred and Fifty Four.

With Bell Bills AND WHEREAS clause (8) of Para MIV of the said Instrument permits such amendments and alterations with the consent of all the Trustees and the sanction of Court.

AND WEEREAS all the Trustees have consented to the alterations and amendments and the sanction of the learned District Judge, Luchtana has been obtained on the Thirtieth day of October, Mineteen Hundred and Fifty Eight.

NOW, THEREFORE, we, the following Trustees of Mankana Sahib Education Trust, namely,

AND WHEREAS the Trustees have by means of Resolution No.5 passed on the Fourteenth day of May, Nineteen Hundred and Fifty Eight, at New Delhi, resolved that Sardar Mahinder Singh Sidhwan, Honorary Secretary of the Trust, be authorised to put in and prosecute the necessary petition in Court and to get the same registered, and have authorised him to take any legal assistance that he deems necessary and incur necessary expenditure in this connection.

This declaration of Trust made this Twenty Sixth day of December, Nineteen Hundred and Fifty Eight (26-12-1958) by the said Trustees through Sardar Mahinder Singh Sidhwan, Honorary Secretary of the Trust, witnesses as follows:-

WHEREAS the Trustees of this Trust are deeply interested in the moral and social uplift of the poor and backward section of people who are at present weak mainly, perhaps, on account of the fact that for ages they have lived and worked under great disabilities;

AND WHEREAS the Trustees feel for all such uplift and for the proper development and maintenance of human character, it is necessary first to raise the intellectual and economic status of these people and that in this age of machine one of the best ways to do so is to provide them -- facilities for industrial, agricultural and technical education and training and thus benefit them to earn their independent living and so stand erect in Society, but that these facilities are not at present available in Nankana Sa to them on an adequate scale.

NOW, THEREFORE, this Instrument of Trust provides as follows: -Mankana Sahib Public Sen. Sec. School

This Trust shall be named " The Nankana Sahib Education Trust."

II. OBJECTS.

The main purposes for which this Trust is founded arer-

- (a) To provide facilities for Civil Mechanical, Electrical, Technical, Agricultural, Industrial and all other types of Engineering and scientific education and training to the weaker or backward and poor section of people in general and to such people of rural areas in particular; and with this end in view, to establish, maintain, and manage an Engineering College, at Ludhiana, or in its suburbs and other Civil Mechanical, Technical, Electrical, Agricultural, Industrial and Scientific Schools and Institutions at suitable places in the State of Punjab, and with the same end in view to set up plants, workshops and other machinery for the production and manufacture of Mechanical, Electrical, Agricultural and Industrial tools, Plants, machinery and goods.
 - (b) To provide facilities and make special arrangements for poor, backward and other deserving students for preparation for competitive examinations and tests for recruitment to the Civil and Military Services and all other services of every description and for admission to the Professional Colleges, Schools and Institutions in India.
 - (c) To supply necessary information for the said purposes to people through Books, Magazines, Papers and otherwise.

III. COMPOSITION AND CONSTITUTION OF THE BOARD OF TRUSTEES.

- A person appointed as Trustee shall assume office as such as soon_he accepts his appointment and informs the President of the Board of Trustees in writing addressed to him of such acceptance and not before. In case he fails to so accept the office within a month of the date of his being informed of such appointment in writing, the office shall be deemed to be vacant.
- (3) The Trustees shall exercise their powers and perform their duties as a Committee and, except as otherwise provided in this Instrument, a resolution passed by a majority of votes of the Trustees in a meeting properly called and held as provided under the rules, shall be deemed to be a joint act of all the Trustees.

The Trustees while acting as a Committee shall be known as
"the Board of Trustees", hereinafter referred to as 'the Board'.

IV. OFFICE-BEARERS AND THEIR FUNCTIONS.

(1) PRESIDENT:

The President of the Shromani Gurdwara Prabandhak Committee for the time being, shall be the President of the Board by virtue of his office. He shall preside over and conduct the proceedings of the meetings of the Board in accordance with the rules of business framed under Para 1 of Article XII in-fra and shall perform such duties as are assigned to him by this Instrument itself and the Rules framed in accordance with the provisions of this Instrument.

(2) Vice- President:

The Board shall at its option elect one or two Vice-Presidents from amongst the Trustees. When two Vice-Presidents are elected, one out of them shall be designated as "Senior Vice-President" and and other as "Junior Vice-President". The Senior Vice-President shall preside over the meetings of the Board in the absence of the President and the Unior Vice-President in the absence of both the President and the Senior Vice-President. The Vice-Presidents besides presiding over the meetings shall perform such other duties as are assigned to them by this Instrument and the rules framed under it.

(3) Secretary:

The Board of Trustees shall elect a Secretary, who may or may not be Trustee. He shall perform such duties and functions as are prescribed by the Board.

V. DUTIES, POWERS AND LIABILITIES OF TRUSTEES:

- The Board shall start, found and run an Engineering College at Ludhiana, or in its suburbs, and other institutions and works, and at such places in the State of Punjab as the Board considers proper.
- (2) The Board may collect funds and acquire land, buildings and other property for the Engineering College and other institutions and works started and managed by it and for all other purposes of the Trust.
- (3) The Board shall incur all the expenses in connection with, and spend the Trust funds, on the purposes of the Trust as herein provided within the limits of the budget duly sanctioned.
- (4)The Trustees shall have all the powers, duties and liabilities assigned or attached to the office of a Trustee under the Indian Trusts Act and shall also suffer, except as otherwise provided in this Instrument, from the disabilities contained in the said Act.
- (5) The Board may appoint a Managing Committee to manage and control the affairs of any Institution founded or run by it. Such Managing Committee shall have the powers, functions and duties expressly given in this Instrument and delegated to it by the Board from Principal

The Board may delegate any of its powers, functions and duties, Bellin [1631142] (6) Rampur Distt. Ludhiana. excepting the powers of :

> (i) Appointment, dismissal, removal and suspension of and imposition of any other penalty on the Principal or head of an Institution.

(ii) Framing of rules and regulations,

(iii) Sanctioning of Budget,

(iv) Appointment of auditors,

(v) Sanctioning of Grades and Cadres of the Staff, to any Managing Committee constituted under the preceding paragraph.

(7) The Board may appoint or employ an Assistant Secretary, or such

The Board may appoint the Principal or head of an institution other Teaching and elerical staff and employees of the institutions. run and founded by it, and may suspend, dismiss, remove or impose other, penalties on them in accordance with the service rules framed by 15, but when a Management Committee of an Institution has been appointed under the provisions of this instrument, this power shall be exercised by that Management Committee in accordance with the rules and regulations framed by that Hanaging Committee and approved by the Trust, except with regard to the appointment, suspension, dismissal, removal of and imposition of penalty on the Principal or head of on institution, which shall in all cases be done by the Board.
- (9) The Board may determine the cadres and grades, fix exclusionts and terms of service of the staff and employees of the institution run and founded by 1t, but when any Managing Counities of an institution, has been appointed, under the provision of this Instrument, this power shall be exercised by that Managing Committee with the approval of the

VIII. ADMISSION AND COURSES OF STUDIES.

- (1)The Board shall frame rules not inconsistent with the provisions of this Instrument for admission of students and --trainees in the institutions run by the Trust, and the admission shall be made strictly in accordance with those rules.
- The Courses of studies at the Engineering College should pre-(2) ferably be the same as prescribed by the University of Punjab for Technical Education and are being followed at the Engineering College of Punjab State, or the State Board of Technical Principal Education for Degree and Diploma classes.

IX. RESERVATION OF SEATS:

Nankana Sahib Public Sen. Sec. School WHEREAS the Trust is created primarily to help the people of Rural areas, who are admittedly a backward or weaker section and the Trust will not be fulfilling its purposes if such people do not get the fullest benefit from the activities of this Trust,

so it is provided that in case the number of candidates is more than the seats available for admission to the Engineering College, or to any other school or Institution of the Trust, seventy percent of the seats shall be filled up from among the candidates whose parents have permanent residence in rural areas, provided such number is available from among candidates who have applied for such admission.

EXPLANATION:

" Rural Area" means areas outside the limit of a Municipality or a Cantonment Board."

X. FUDNS ACCOUNTS:

- (1) The accounts shall be opened in the name of the Trust with bankers approved for this purpose under the Indian Trusts Act, or by the Reserve Bank of India.
- (2) The Trust money shall not be advanced as loan to any person or individual or company, or society or other Association or Body, except those approved under the Indian Trusts Act for this purpose.
- All the incomes of the Trust and its institutions shall first (3) be credited to the accounts of Trust with the bankers and all withdrawals shall be made by cheques.
- The accounts of the Trust shall be operated upon by the Trustees (4)under the joint signatures of the President and the Secretary for the time being, of the Board of Trustees.
- The account of a Managing Committee appointed under this Instru-(5) ment, if any, shall be operated upon under the joint signatures of the President and Secretary of the Managing Committee but the Board of Trustees or with its approval the Managing Committee may, where necessary, prescribe any other mode for operationing its accounts. - (?) No Managing Committee appointed under this Instrument shall have an income of its own and any income that eccrues to it must be credited to the Trust Accounts and form part of the Trust funds:
- (8) When the Trust property consists of money and expect be applied immediately, or at an early date, to the purposes of the Trust, the Beard may invest that money as approved by it unanimously.

 In the absence of unanimous decision the money shall be invested as provided in Section 20 of the Indian Trusts Act, 1861.

IL. MINIT

- (1) The Board and the Namaging Committee shall keep, for ognise to be kept, regular accounts of money and other property and stocks. The accounts of the Trust and the Namaging Committees shall be audited annually by some Chartered Auditors apprinted by the Board.
- (2) The Balance sheet of the accounts duly sudited shall be published for public information within three months of the report of the auditors.

XII. GENERAL!

- (1) (a) The Board shall make rules and bye-laws, not inconsistent with this Instrument, to carry out the purposes of the Trust and to regulate its own procedure and conduct of the business of the Remaging Committees.

- (vi) Prescribing the procedure and method of summoning and holding of the meetings of the Board and Managing Committees and main-teining their records.
- (2) Every Trustee and every member of a Managing Committee shall have only one vote, but in case of a tick me Chairman of the -meeting may exercise an additional or casting vote.
- (3)For the purposes of sections 42 and 43 of the Indian Trusts Act, the President and the Secretary of the Board of Trustees jointly, or under their joint signatures, may perform the duties, or exercise the powers and do the acts referred to in the said sections, until or unless the Trustees by a resolution provide otherwise.
- (4) The President and the Secretary of the Board may also act for and on behalf of the Board in all the suits and other proceedings in the name of the Trust or the Trustees, until and unless the Trustees, by a resolution provide otherwise.
- (5) No alteration or amendment in any of the provisions of this Instrument shall be made, except by the unanimous vote of all the Trustees present at the meeting specially called for the purpose with a clear notice of thirty days and with the sanction of the Court.
- (6) The quorum for a meeting of the Board of Trustees shall be 1/3rd. of the number of the Trustees with a minimum of three.
- (7) Notwithstanding the provisions for the expiry of the term of his office as embodied in Article VI Supra, a Trustee or a member of a Managing Committee shall continue to hold office till the appointment of a person to take his place as such.

The powers, duties, liabilities and acts or proceedings and (8) Rampur Distt. Ludhiana. deemed to have been suspended or invalidated merely by the existence of a vacancy in the office of one or more Trustees or members of the Managing Committee.

If the Trust or its purpose fails for any reason beyond the (9) control of the Trustees and the Board unanimously decides that the Trust can no longer truly and effectively serve its real
